For fabrication, supply, Installation & Grouting of galvanized Module Mounting Structure with Parking Facilities for SPVPP in Rajnandgaon (Motipur to Dongargarh) (Chhattisgarh).

Limited short term Tender are hereby invited from experienced manufacturers or their authorized dealers registered in CREDA as a System Integrator/Vendor under SPV Programme in Financial year 2018-19 for fabrication, supply, Installation & Grouting of galvanized Module Mounting Structure with parking Facilities for SPVPP anywhere in Chhattisgarh.

1. **Minimum Eligibility Criteria:-** Tendered should have experience on fabrication & Installation of Module Mounting Structure with parking Facilities for SPVPP and having valid registration in CREDA as a System Integrator/Vendor under SPV Programme in Financial year 2018-19.

System Integrator/Vendor who fails to accomplish their assigned projects timely or to provide service/onsite warranty timely for their non functional system and who are subsequently warned by CREDA for the same may be treated as defaulters and they may not be allowed to participate in this tender.

2. **Tender Document Fee:-** Tender document fee Rs. 2,000/- can be furnished in the form of Bank Draft/Pay order on any Scheduled Bank made payable to ``CREDA`` at Rajnandgaon.
3. **Earnest Money Deposit* (EMD):-** The earnest money deposit Rs. 30,000/- can be furnished in the form of Bank Draft/Pay order on any Scheduled Bank made payable to ``CREDA`` at Rajnandgaon. EMD submitted in any other form e.g. Cash/Bank Guarantee/FDR/TDR etc shall not be accepted. {Exemption from EMD shall be given only to those companies who submit the valid competency certificate on which it should be clearly mentioned that, ``the company registered in Chhattisgarh for manufacturing of that particular product``.
4. **Payment Terms:-**
 - (A) 90% after successful completion of allotted work as per subsequent inspection by CREDA.
 - (B) Balance 10% after two year of satisfactory completion of allotted work, however this balance 10% payment may also be released after completion of work and as per subsequent inspection by CREDA against Bank Guarantee/FDR of equivalent amount of any Nationalized Bank for a period of two year.

The above Rates should be inclusive of Excise, insurance, freight, loading, unloading, transportation and including all GST applicable.

5. FIXATION OF RATES AND AWARD OF WORK:-

Rates shall be decided on the basis of analysis of quoted prices by eligible bidders and reasonability. First three eligible bidders shall be called for consent and subsequent agreement on lowest approved rates by tender committee. Work shall be distributed among these three eligible bidders on the lowest approved rates as follows-

A. L-1 Bidder -100%

However, CREDA reserves the rights to amend the above conditions and may allot the work to the other bidders to complete the work on time.

All the materials required for completion of work as per work Order issued shall be kept at site in the custody of the contractor. CREDA shall not be responsible for any loss or damage of any material during the installation.

6. **Technical specifications of galvanized module Mounting Structure with parking facilities: - As per drawing enclosed.**
7. Eligible tenderer should have to submit the cost breakups and details of all type of taxes (All GST etc.) with tender Documents.
8. Your offer must reach this office on or before 1.00 PM dt 18/01/2019
9. **Warrantee**—05 Years from the date of completion of work against any manufacturing/ installation defect.
10. Site- Rajnandgaon (Motipur to Dongargarh) Chhattisgarh.
11. CREDA reserve rights to accept or reject any offer without assigning any reason thereof.
