CAVEAT UNDER SECTION 142 OF THE CHHATTISGARH HIGH COURT RULES 2007

The caveator named above most respectfully begs to submit as under:-

1. That the caveator is Chhattisgarh State Renewable Energy Development Agency (CREDA), and has initiated Tender No. **2065/CREDA/HOR/RE-III/SDP/BID/2020**, dated 09-06-2020 for inviting sealed bids for Survey, design, supply, installation, and commissioning of Solar Photovoltaic Drinking Water pumps with five years COMC, onsite Warrantee, Insurance For anywhere in state of Chhattisgarh from registered System integrators of CREDA for SPV with 3 years Track record in Solar Dual Pumps as per required specification detailed in the floated tender.
2. That, Any person from public at large aggrieved by the recruitment process may file a writ petition before the Hon'ble High Court of Chhattisgarh and may pray for the stay to the tender process of the tender No. **2065/CREDA/HOR/RE-III/SDP/BID/2020**, dated 09-06-2020, by the caveator agency. Copy of which is annexed herewith as **Annexure C-1**.
3. That, there have also been subsequent corrigendum to the Tender no. **2065/CREDA/HOR/RE-III/SDP/BID/2020**, dated 09-06-2020, and the caveator/proposed respondent apprehend that during the course of tender and it's process, writ petitions may be preferred by the aggrieved parties seeking interim relief/reliefs.
4. That, the caveator has engaged Shri Devershi Thakur Advocate as his counsel to argue and oppose the application for interim relief filed by the proposed petitioner along with their petition. It is also submitted that the copy of this caveat application is being published in the news papers and the copy of the published caveat notice is filed herewith as **Annexure C-2**.
5. That in the facts and circumstances of the case this Hon'ble Court may kindly permit the caveator to appear through his counsel and argue his case at the time of hearing on the application for grant of interim relief.

PRAYER

It is, therefore, prayed that this Hon'ble Court may kindly be allow this application and permit the caveator to appear and argue at the time of hearing on the petition / interim application, if any filed by the proposed petitioner, in the interest of justice.
