**// Clarification Notice regarding Quotation of Rates in GeM Portal for
Tender No. 5000/CREDA/SWHS/2026-27 Date 24-07-2026//**

In continuation of Tender No. 5000 for “Standardization of rates for Supply, Installation and Commissioning of Solar Water Heating Systems of ETC & FPC Model of various capacities including 5 years CMC and onsite warranty anywhere in state of Chhattisgarh”, it is hereby clarified that the bidder shall quote/fill the rate excluding GST in the GeM Portal, as specifically stipulated in the Tender Document and ATC.

The following shall be applicable:

1. The rate entered/quoted by the bidder in the GeM Portal shall be the basic rate excluding GST.
2. GST shall not be included in the rate quoted/entered by the bidder in the GeM Portal.
3. GST shall be applicable/payable separately at the applicable statutory rate, subject to the provisions of the Tender Document/ATC and prevailing statutory provisions.
4. For the purpose of financial evaluation and determination of L1, the basic rate excluding GST quoted by the bidder shall be considered.
5. If considered necessary, CREDA reserves the right to seek clarification from any bidder regarding the rate quoted, including clarification regarding the GST component, wherever required for proper evaluation of the bid.
6. Any clarification sought by CREDA shall be limited to clarification/explanation of the rate already quoted and shall not be construed as providing an opportunity to the bidder to alter, revise, increase or decrease its quoted rate or otherwise modify its financial bid.
7. All bidders are advised to carefully fill the price bid in the GeM Portal in accordance with this clarification and the provisions of the Tender Document/ATC.
8. All other terms and conditions regarding Eligibility, Experience, Network, Turnover etc shall remain strictly as per ATC, Tender Document of CREDA, including its Corrigendums, Clarifications, Addendums etc.
9. **In case any bidder has already submitted the Price Bid, they are requested to resubmit the same after incorporating the above clarification.**
