# Terms & Conditions:-

### 1. Scope of work:-

Microsoft 365 Business Basic plan:

The party shall provide the license for the above plan, as per the details (without any change) mentioned in the link - <a href="https://bit.ly/3yD0Ydz">https://bit.ly/3yD0Ydz</a>.

### 2. Eligibility:-

a. The party should be a firm registered/incorporated under Companies Act, 1956 or Companies Act, 2013/ and further amendment (s),

#### **OR**

A registered partnership firm (registered under section 59 of the Partnership Act, 1932)

### OR

A limited liability partnership (under the Limited Liability Partnership Act, 2002)

#### AND:

Operating for the last five (or more) years in IT/ITeS Services as of 31st March 2022.

- b. The Party should be an Information Technology Solution and Service Provider with a registered office and operations in India. The Party should be operational in India for at least the last five financial years as of 31st March 2022.
- c. The party should have experience of providing IT/ITeS solutions and services to central / state government bodies/PSUs/SPSUs/agencies etc. in the last five years. Duly attested copies of experience certificate or work orders issued by Competent Authorities of Central/State Government bodies/PSUs/SPSUs/Agencies etc. must be submitted. LOIs for such work shall not be considered.
- d. Turnover and Networth: The Party should have a minimum aggregate turnover of INR 2Cr in last five financial years in IT/ITeS Services as of 31st March 2022. Certified copies of the annual returns submitted to the Registrar of Companies/Income Tax Authorities should be enclosed. For the preceding years a Certified Summarized Sheet of turnover certified by registered CA must be enclosed.
- e. The party must have to submit a positive net worth of INR 20 lacs as on 31<sup>st</sup> March 2021/22. The networth certificate shall also have to be duly authorized by a registered CA as in sub clause—c above.

- f. The party must be an Authorized Reseller of Microsoft products and services of Gold Category and shall have to submit relevant authorization of dealership/partnership of the firm of gold category with Microsoft.
- g. The Party should not be blacklisted by any Central/State Government, Ministry or Agency for breach of Contractual Conditions. The Party should also not be entangled in any legal disputes with any Govt. / PSU body. A self-declaration regarding the same shall have to be submitted by the party.
- h. Party shall have to provide round the year software support to CREDA excluding Microsoft's own 24/7 support/help desk.
