Sub:-Regarding revocation of debarment of your firm with CREDA.

Your firm has installed 10203 nos of solar home lighting systems in different villages of Chhattisgarh but out of these, 1532 nos of systems are nonfunctional till date. CREDA's field offices and head office have been continuously issued notices to your firm for the rectification of nonfunctional systems but as per the reporting of our field offices your firm has taken no initiative since long. Despite of communicating notices through post, emails etc. your local representative is falsely complaining about non receipt of notices. Even letter sent through speed post, was not received by your local office. These activities are example of your ignorance towards the prestigious program initiated by Govt. of India i.e. "Saubhagya scheme". Subsequently CREDA, has debarred your firm for one year as per the tender terms, vide our letter referred at S.no.02.


You have informed CREDA vide refernced letter no.1 that few systems have been repaired by you in last three months, but the progress is very slow and just partial completion of works is not going to solve CREDA's purpose since huge number of systems are still non-functional and faulty, list of which is attached for your reference.

Such an ignorant approach, despite having a long term engagement with CREDA conveys your ignorance of the gravity of the issue. You are hereby directed to make the systems functional within 60 day's period from the issuance of this letter as agreed by you simultaneously you are requested to inform the concerned field offices and the undersigned, about the progress of repair work.

Considering your plea, we are revoking your debarment and providing you a time of 60 days, failing which, CREDA will be forced to take necessary action as per the terms & conditions of the aforementioned tender at your responsibility.
